- All Participants will receive a reversible jersey. The cost is only \$30 for each participant. Registration ends December 29, 2011. **After December 29th, there may be an additional \$10 late fee per participant (\$40 total) and your child's name may be placed on a waiting list.**
- Because of limited gym space, registrations will be accepted on a first-come, first-served basis, so **EARLY REGISTRATION IS STRONGLY ENCOURAGED!** Return this Registration Form and Liability Release (along with payment) by **Thursday, December 29, 2011** to: Town of Pinetop-Lakeside Parks and Recreation at 1360 N. - All practices and games will be held on Saturday mornings starting in January and will continue for 8 weeks. The fun begins with a basketball clinic Saturday, January 7th. Teams will be organized after the clinic. Participants will be assigned to a team based upon their skill level, height, prior experience, etc. **There will be no requests taken to be placed with a particular coach or team.**
- All games and practices will be held at one or more of the gyms at Blue Ridge High School. We anticipate 90-minute sessions on Saturday mornings starting at 8:30 a.m. Teams will be organized into four divisions: 3rd & 4th grade girls (all girls 3rd through 6th may be combined depending on the number of 5th & 6th grade girls who sign up) – 3rd & 4th grade boys – 5th & 6th grade girls – and 5th & 6th grade boys.
- Participants are not required to furnish their own basketballs, but having your own ball will be helpful for practices and working on drills on your own. The 5th & 6th grade boys division uses a regulation size ball (29.5) and the other three divisions use the intermediate size (28.5).
- The program can only succeed with the support of the parents. We will need volunteers to coach, ref, keep score, supervise, and help out in other ways. Please remember that this program is intended to teach young people the fun in the FUNdamentals of basketball! This is not a competitive program. No standings will be kept!
